The participant agrees that the Great Northern Exhibition, Collingwood Agricultural Society and their employees, agents, representatives and sponsors shall not be liable for any personal injury, death or property loss. The participant releases the Great Northern Exhibition, Collingwood Agricultural Society and their employees, agents, representatives and sponsors and waives all claims with respect thereto. The participant agrees that any litigation involving the parties named above shall be brought solely within the Province of Ontario and shall be within the Province of Ontario and shall be within the exclusive jurisdiction of the Courts of the Province of Ontario. The participant further agrees that these conditions and any rights, duties and obligations as between the above named parties and the participant shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario and no other jurisdiction.
